**ORDER AFFIRMING RECOMMENDED DECISION

On August 18, 2011, the United States Magistrate Judge filed with the court, with copies to counsel, her Recommended Decision on Motion for Judgment on the Pleadings and for Summary Judgment. The time within which to file objections expired on September 6, 2011, and no objections have been filed.
