**ORDER AFFIRMING THE
RECOMMENDED DECISIONS OF THE MAGISTRATE JUDGE**

The United States Magistrate Judge filed with the Court on February 4, 2004 and February 26, 2005, her Recommended Decisions (#33 and #38, respectively). The Plaintiff filed her objections to the Recommended Decision on February 17, 2004 (#36). I have reviewed and considered both of the Magistrate Judge's Recommended Decisions, together with the entire record; I have made a de novo determination of all matters adjudicated by the Magistrate Judge's Recommended Decisions; and I concur with the recommendations of the United States Magistrate Judge for the reasons set forth in her Recommended Decisions, and determine that no further proceeding is necessary.

1. It is therefore ORDERED that the Recommended Decisions of the Magistrate Judge are hereby AFFIRMED.
2. Plaintiff was given ten days from the date of

the Magistrate Judge's Recommended Decision (#33) to Show Cause why her complaint should not be Dismissed and to file a clear explanation of her legal claim, identifying only the facts material to her claim, and explaining how each defendant that she still wished to hold liable actually participated in allegedly violating her rights.

Plaintiff failed to Show Cause as ordered by the Magistrate Judge. It is ORDERED that this case is DISMISSED.
