**ORDER ON DEFENDANT’S SECOND MOTION
FOR ENLARGEMENT OF TIME**

Before the Court is Defendant’s Second Motion for Enlargement of Time (Docket # 133). The Motion is hereby GRANTED as explained in this Order.

In the current motion, Defense counsel represents that he needs additional time to confer with his client and that putting this case on a more extended schedule will not delay the Defendant’s release. Defense counsel also indicates that he wishes to file an amended motion for sentence reduction that will provide the court with undoubtedly helpful factual information and legal argument. Based on these representations, the Court will extend the deadline for the filing of an amended motion for sentence reduction until February 22, 2008.

As contemplated by the original Scheduling Order, the Government shall have three weeks to file its response to the amended motion. The Government’s response is due on or before March 14, 2008.

Defendant’s reply is due on or before March 31, 2008, which will allow Defense counsel additional time to communicate with the Defendant following the filing of the Government’s response. The reply shall include all of the information previously requested in the Scheduling Order.

The schedule laid out in this Order supersedes the schedules previously laid out in the Court's January 24, 2008 Order (Docket # 132) and the original Scheduling Order (Docket # 126).
