**ORDER ON GOVERNMENT’S MOTION FOR REVIEW OF RELEASE ORDER**

Before the Court is the Government’s Appeal of the Magistrate Judge’s Order Setting Conditions of Release (Docket # 29). Having conducted a prompt *de novo* review of the matter, including a review of the June 11, 2008 hearing transcript, the Court is satisfied that the Magistrate Judge’s Order Setting Conditions of Release with Addendum (Docket # 22 & 28) is entirely correct and complies with the requirements of 18 U.S.C § 3142.

I concur with the decision of the United States Magistrate Judge for the reasons set forth in the Addendum to the Order Setting Conditions of Release, and determine that no further proceeding is necessary.

Therefore, it is hereby ORDERED that the Government’s Appeal (Docket # 29) is DENIED and the June 11, 2008 Order Setting Conditions of Release is hereby AFFIRMED. The Stay of the Order Setting Conditions of Release (Docket # 26) is hereby lifted.
