**ORDER ON DEFENDANT’S MOTION
REGARDING COMPELLED MEDICAL TESTING**

Before the Court is the Defendant’s Sealed Ex Parte Motion Regarding Compelled Medical Testing (Docket # 278). The Government is also directed to mail a copy of its response directly to Defendant and to ensure that Attorneys Rodway and Hewes receive notice of all filings related to the pending motion.
