It is **ORDERED** that Defendants' Motion for Partial Summary Judgment (ECF No. 17) is **GRANTED IN PART** dismissing all claims that Defendants have addressed in said Motion, except for the First Amendment retaliation claim against Defendants Pickering and LeBlanc. The excessive force claim against Defendant Purington was not the subject of the motion, and thus, that claim remains in the case.
