**ORDER AFFIRMING THE  
ORDERS OF THE MAGISTRATE JUDGE**

The United States Magistrate Judge issued an Order on February 23, 2006, granting Defendant's Objection to Plaintiff's Jury Trial Demand. (Docket # 14). On March 1, 2006, Plaintiff moved for reconsideration, which motion was denied by the Magistrate Judge on March 17, 2006. (Docket # 18). The Plaintiff filed her objections to the Order denying the Motion for Reconsideration on March 21, 2006 (Docket # 19) and the Defendant filed its response to those objections on March 27, 2006 (Docket # 20).<sup>1</sup> I have considered said objections, and pursuant to Fed. R. Civ. P. 72(a), I have determined that the Orders of the Magistrate Judge are neither clearly erroneous nor contrary to law. I concur with the recommendations of the United States Magistrate Judge for the reasons set forth in her Orders, and determine that no further proceeding is necessary. It is therefore ORDERED that the Magistrate Judge's Order on Jury Demand (Docket # 14) and Order denying Motion for Reconsideration (Docket # 18) are AFFIRMED.

<sup>1</sup> The Plaintiff's objection may technically be only to the Magistrate Judge's denial of her request for reconsideration of the Order granting Defendant's objection to jury demand. It is more likely that Plaintiff intended to object to both the original Order and the later denial of her request for reconsideration. This Court has reviewed both Orders, February 23, 2006 and March 17, 2006, and affirms each.
