**ORDER AFFIRMING THE

2. It is further ORDERED that that the Complaint (Docket # 1) be and hereby is DISMISSED pursuant to 28 U.S.C. § 1915A(b).
3. It is further ORDERED that the Plaintiff's Motion for Leave to Proceed *in forma pauperis* (Docket # 2) be and hereby is DENIED.
4. It is further ORDERED that the Plaintiff's Motion for Leave to File Supplemental Amendments to Complaint (Docket # 22) be and hereby is DENIED on the ground that the requested amendments remain legally insufficient and would not state a cognizable claim.
