ORDER STRIKING MOTION FOR RECONSIDERATION

On June 30, 2011, the Court issued an Order denying Chukwuma E. Azubuko's motion for three judge court. *Order on Mot. for Three Judge Court* (Docket # 18). In the Order in which the Court concluded that Mr. Azubuko's motion was frivolous, the Court issued a *Cok* warning to Mr. Azubuko that "filing restrictions may be in the offing" and that "[g]roundless and inappropriate filings will not be tolerated." *Id.* at 3-4. In defiance of that Order, Mr. Azubuko on July 7, 2011 filed a motion for reconsideration of the Court's June 30, 2011 Order. *Pls.' Mot. for Recons. of Three-Judge Court* (Docket # 19). The motion, which is itself frivolous, violates the Court's June 30, 2011 Order. The Court ORDERS that the Motion for Reconsideration of Three-Judge Court be and it hereby is STRICKEN from the docket.

The Court further ORDERS that before any lawsuits or pleadings by Chukwuma E. Azubuko may be docketed in this Court, the Clerk is directed to

bring the lawsuit or pleading to this Judge's attention. With the exception of Mr. Azubuko's right to file a notice of appeal, if the lawsuit or pleading involves any claim against the Dedham Massachusetts Police Department or against any other persons arising out of an incident that occurred in Dedham Massachusetts in April 2005, the Court will direct the Clerk not to docket the lawsuit or pleading. The Court hereby ENJOINS Chukwuma E. Azubuko from making any similar filings without prior leave of this Court.
