If a Single Login Profile (SLP) password is forgotten, expired or account is locked follow the below steps.

Steps to Access eVoucher:

Step 1. Navigate to CJA eVoucher for the District of Maine: https://evadweb.ev.uscourts.gov/CJA_mex_prod/CJAeVoucher/

Step 2. Log into the eVoucher system with the user's Single Login Profile credentials. Enter the email address and click **Next**.

If the password has expired, was entered incorrectly, or if forgotten, an error message will appear stating that the password is expired, invalid or locked.

Enter the correct answer and then click **Reset your password**. An email will be sent notifying the user that an unsuccessful attempt was made to log into the account and that the password must be reset.

Locked Accounts

You can attempt to create a Single Login Profile or sign in with an existing Single Login Profile a maximum of six times. If you attempt a seventh time and are unsuccessful, your account locks and you can no longer enter a correct password at this time. You must contact the court to unlock your account. Additionally, you will receive an email notifying you that an unsuccessful attempt was made to reset your password.

Login failed. Invalid username or password or your account is locked. Please contact an eVoucher Administrator for assistance.

Note: If you make fewer than seven consecutive attempts, the allowed number of unsuccessful creation attempts resets to zero after 30 minutes.
